Prudential plc (the “**Company**”) confirms that the share repurchase programme that was announced on 11 June 2024 and commenced on 12 June 2024 (the “**Programme**”) has now completed.

Since the commencement of the Programme, the Company has repurchased 758,614 ordinary shares in aggregate at a volume weighted average price of 720.8428 pence per ordinary share for a total consideration of approximately £5,468,415.
